MEMBERSHIP REQUIREMENTS

MEMBERSHIP IS GRANTED AFTER THE FOLLOWING REQUIREMENTS ARE MET:

1. A completed membership application, including agent's and broker's signatures, must be submitted to the Board.
2. Dues must be paid.*
3. All new members must attend a one hour in-class Local Bartow Area Board Training course given by the Bartow Area Board of REALTORS®. This must be done within 6 months of submitting your application to the Board in order to start counting your Professional Achiever's Circle sales credit from the date your application was received in the Board office. Additionally, all new members must also complete a qualified New Member Code of Ethics Orientation course. You may: Attend a three hour in-class Orientation session, which is offered every other month at the Bartow Area Board of REALTORS®' office. This course will provide you with 3 hours of Continuing Education credit;

OR, you may take the National Association of REALTORS®, New Member Code of Ethics Orientation online at www.realtor.org ("Take the Code of Ethics" training link and then "New Member Code of Ethics Orientation" link).

Scheduled dates and times of these classes can be found online at www.bartowrealtors.com.

If you are currently a member of another REALTOR® Association or have held membership in the past with the Bartow Area Board of REALTORS® and you have already attended a new member orientation course, then you do not need to attend the New Member Code of Ethics Orientation course again nor the Local Bartow Area Board Training. You must submit proof of your New Member Orientation completion from your previous or current REALTOR association in order to bypass attendance at either of these training sessions. 4. The application must be approved by the Membership Committee and the Board of Directors.

2012 REALTOR DUES INFORMATION

July 1, 2011 - June 30, 2012

Annual membership dues for the Designated REALTOR® are calculated at \$370.00. Each licensed agent within the Designated REALTORS® office will also pay \$370.00 in order to become a REALTOR® member of the Board. All agents applying to the Board must pay the dues, fill out an application and attend an Orientation session before being approved for full membership.

DESIGNATED REALTOR® defined

Principal Partner, Corporate Officer, Trustee, or Branch Manager of a Real Estate firm. There is only one Designated REALTOR® per company. The DESIGNATED REALTOR® is responsible for paying dues for all licensed agents within his or her organization.

REALTOR® defined

All agents within an office of a Designated REALTOR® that hold an active real estate license who become a member of the Board.
